# **ASF BOD Meeting Report:** Lorie Koppenberg reported on the ASF Mtg.

Topics discussed:

- Septic goes to bid in March to be completed by July
- Roof of the barn was discussed
- Plans are in motion to construct another Rasmussen pavilion to be erected between Raven Hall and the turkey leg booth.
- David Forkner reported that Thom and Ray visited an amphitheater in Atlanta. This particular venue accommodates 10K people and is thought to be a good example of what would benefit the ASF. It will be located in the Equestrian area.

AVA discussion on this topic - amphitheater is too big. The capacity is more than the daily fair attendance. Unrealistic. It would draw the fair patrons away from the booths given the new proposed location. Fairgoers often come to the Fair only to attend a concert and won't have a need to actually walk through the fairgrounds giving their business to the vendors.

#### **Old Business:**

- Website New articles need written but there are no volunteers to write any.

  Larry and TJ agreed to look into writing a few articles. The new
  membership application form on website needs a little modifying. Pat
  will be working on it.
- ASF BOD Annual Meeting is coming up with election of ASF BOD members. John Tracy, Steve Brown and Lorie Koppenberg are candidates running for election. All candidates endorse the mail in ballot bylaw change. AVA agrees that each candidate is acceptable and highly qualified as potential ASF BOD members. AVA decided to endorse Lori. AVA will mail out a postcard endorsement to ASF membership showing their support of Lori. Sariah agreed to make and mail out the postcards.

## **New Business:**

- TJ will be setting up a liaison meeting with ASF to address our topics. One topic concerns the possibility of new non-profit food booths being set up. AVA would like to know the policy concerning the fair attendance needed to add new food booths. It is thought that there is already too much food with plenty of variety in place.
- Motion was made and carried for Larry to use the AVA non-profit status to support the Sunshine Kids through a dinner fundraiser.
- AVA agreed that it is important to keep our NICA membership.
- Chadwick is willing to be the AVA representative for the KPSF & TVSF.
- AVA has agreed that KPSF and TVSF can be associate members of AVA, but without voting rights.
- The AVA rep. will be a contact for the DEC, Access Alaska, Fire Depts, and other agencies during the ASF board meetings.
- Motion made and carried to donate \$200 to the 4-H program at KPSF.
